**ANNOUNCEMENT**

New Millennium, a division of Steel Dynamics, Inc., announces the strategic acquisition of manufacturing and office facilities in the southwestern and western United States. Three major facilities have been acquired from Commercial Metals Corporation (CMC), which has exited from the steel joist and metal decking marketplace. CMC was the second largest producer of steel joists and metal deck, behind Nucor's Vulcraft division. By these acquisitions, New Millennium is the second largest provider in the steel joists and metal decking market.

**CORE BUSINESS**

New Millennium Building Systems designs and manufactures steel joists, metal decking, castellated beams and related, highly engineered, structural steel products for the non-residential construction markets.

**UPGRADES OF ACQUIRED FACILITIES**

New Millennium is immediately investing in the upgrade and staffing of all acquired facilities to align with the company's high-speed and uniquely flexible service model.

**NEW EMPLOYMENT**

Staffing of the acquired facilities will result in the new hire of people for the new facilities as they ramp up. The company will also strategically transfer managers and employees, resulting in the new hire of people to replace those transferred.

**SERVICES**

New Millennium's capabilities now extending nationwide due to the acquisitions include BIM-based digital design collaboration, detailing, engineering, manufacturing, and delivery.

**PRODUCTS**

New Millennium's structural steel products, available nationwide, include roll-formed and rod type standard steel joists, channel and rod type special profile steel joists, standard and specialty metal decking, and castellated beams. The company also provides engineered steel materials for the metal buildings market, nationwide.

## MARKET IMPLICATIONS

With the purchase of these CMC assets, New Millennium is the nation's second largest provider of steel joists and metal decking. The acquisition of the three facilities signals the resolve of New Millennium and parent company Steel Dynamics, Inc. to leverage proven competitive advantages in service of steel fabricators and owner-accountable steel project teams throughout the United States, Canada and Mexico.


## HISTORY

Both plants have the latest technology and innovations available today. A merger with John W. Hancock, Jr., LLC and Socar Inc. in 2006 has resulted in a dynamic team of people with deep industry experience. The former Hancock plant in Salem VA has undergone extensive renovations and equipment upgrades that have converted it into one of the most advanced and efficient joist production facilities in the country.
